## POLICIES AND PROCEDURES

For the smooth operation of the Summer Camp programme and to ensure the safety and overall well-being of all children, parents and guardians are required to carefully read and understand all MSC Summer Camp policies and procedures. These documents are available online.

### Age Range of Children

The summer camp is planned and designed to cater for children aged 3 to 10 years, with all children grouped according to their age.

### Safety at the premises

Personal sanitising products for children are to be supplied by parents/guardians and are to be brought to the summer camp daily. These may include anti-bacterial wipes and/or hand sanitiser with at least 70% alcohol. Washing of hands and use of sanitisers at the premises shall be rigorously monitored and performed at regular intervals.

Unauthorised personnel are not allowed at the designated activity areas. Only children, authorised personnel and Management are allowed. No parents or guardians are to be allowed at the designated activity areas at any time, except for the designated drop-off and pick-up points.

### Day to Day Requirements

In order to provide a better service, we kindly ask you to read through and take note of the points outlined below.

- The Marsa Sports Club operates a **NUT-FREE** Summer Camp (read the [Nut-Free policy](#)).
- **Label all belongings** of your child/ren including bathing wear, water bottles and food containers.
- We highly recommend **light lunches**, fruits and lots of water.
- Children should come prepared from home with **Sunblock Protection**.
- Children should wear caps/hats on a daily basis.
- **Running shoes** (exclusively non-slip) should be worn for all activities.
- Non-slip swim water shoes should **only** be worn during Swimming lessons and changed once the lesson is over.
- Jewellery, including earrings, is not permitted.
- Hair must be neatly tied up.
- No mobiles/gadgets are allowed.

## Swimming sessions

For the children's convenience, kindly note that for the swimming sessions the children need to come wearing their swimming suits and to have a change of underwear for after the swimming lesson. It is also recommended that the children, especially the younger ones, are equipped with a fresh change of clothes since this will keep them more comfortable during the day following the swimming sessions. A swimming cap and goggles are mandatory during swimming and children will not be allowed to swim without the proper gear. No jewellery, including earrings, are allowed. Children are expected to follow all the instructions given by their coaches at all times.

**Important: Sunblock to be applied from home for the children**

## Custody of Children

In cases such as single parents, separated parents and adopted children, legal papers are to be presented prior to the commencement of the Summer Camp or as for children already attending the Summer Camp, as soon as the legal procedures are completed. The Marsa Sports Club will not be held responsible for any incidents connected with this matter if legal papers are not handed over to the Marsa Sports Club.

## Children's Food, Snacks and Drinks Policy

MSC Summer Camp promotes healthy living and encourages parents to provide nutritious snacks and meals for their children. Foods containing sweets or excessive sugar are discouraged to support children's overall health and well-being. In addition, MSC Summer Camp has a strict nut-free policy, and any food items containing nuts are strictly prohibited to ensure the safety of all children. To maintain a safe environment, children are not permitted to share food with one another. Children under five should not be given popcorn as a snack because it is a significant choking hazard.

### Drinks

Children are required to bring a flask filled with water to Summer Camp each day. The camp provides water dispensers, allowing children to easily refill their flasks whenever needed to stay hydrated throughout the day.

### Birthday Celebrations

At MSC Summer Camp, birthdays are celebrated in a special and safe manner that does not involve cakes or other shared treats. This policy, together with the nut-free rule, helps prevent allergic reactions and ensures the safety of all children.



## Child Collection Policy

Only individuals explicitly authorised by the parents are permitted to collect children at dismissal. These authorised individuals must present the MSC Summer Camp digital **Pickup Permission Pass** (PPP) provided to them by the parents, as proof of their authorisation to collect the child. The MSC Summer Camp will issue parents a uniquely identifiable **Pickup Permission Pass** (PPP), and it is the sole responsibility of the parents to share this pass with trusted individuals.

For any changes to the usual collection arrangements, parents are to notify the MSC Summer Camp Management via email or WhatsApp at least one day in advance. This ensures a smooth and secure handover process for all parties involved.

## Sick Children Policy

If there are signs of illness before arriving to the Summer Camp, the children should be kept at home for their own benefit.

Children showing signs of fever or other symptoms of illness before entering the Summer Camp will not be permitted entry. In such cases, parents/guardians will be advised to take the child home and/or consult a doctor.

Any children resulting in having fever or other sickness symptoms during the Summer Camp's operating hours, they would need to be isolated until their parents/guardians collect them to leave the premises as quickly as possible. In this case, the parents/guardians of the children will be called to collect the child as quickly as possible.

In any circumstance, parents/guardians of children who are sick will be requested to provide a doctor's certificate attesting that the child is no longer sick and is fit to attend, before returning to the Summer Camp. Please refer to the medical certificate template in Appendix 1 at the end of this document.

In exceptional circumstances, medicines will be given upon presentation of a doctor's prescription. Nevertheless, all parents/guardians are advised not to send their children to the Summer Camp if they are on Calpol, Arfen, Neurofen, Voltaren and/or any other pain killer and/or other medication that is used to bring down a high temperature (fever).

## Attendance Policy

Children are signed in and attendance is taken during each lesson. Parents/guardians are obliged to inform the Summer Camp Management if their child/ren will not be attending the Summer Camp and to provide the reason/s.

In case of sickness, parents/guardians are to inform the Summer Camp Management with the date of return of their child/ren to the Summer Camp as agreed with the child's physician. In this case, the children will be allowed back upon presentation of a medical certificate. As for the type of medical certificate required kindly refer to Appendix 1 of this document. No other types of medical certificates will be accepted.

On the other hand, if a child is not going to attend the Summer Camp for other reasons such as: medical appointment in Hospital, Dentist, etc. parents/guardians are still to inform the Management beforehand. Absence for other reasons such as going on holiday etc., parents/guardians are to inform the Management during which period the child/ren will be away.

Please note that the Marsa Sports Club Summer Camp cannot be held responsible for children who fail to report and register their attendance. It is the sole responsibility of the parents/guardians to ensure their child/ren are registered upon entry to the Summer Camp, unless they have informed the Summer Camp's management of the child/ren's absence due to illness, a medical appointment, a holiday or other reasons.

## Hair Care Policy

Children found with hair lice and/or nits are to be picked up and treated at home until the scalp and hair are rid of lice and nits. This will mitigate transmission. In instances where this condition is discovered at home, you are kindly requested to inform the Summer Camp Management in order to advise other parents/guardians to check their children accordingly. All reports will be kept confidential.

## Behaviour Policy

It is important to note that although this is a summer camp, discipline must be observed at all times and any misbehaviour will not be tolerated. The Summer Camp Management reserves the right to change the group of a child should he/she be disturbing class activities and affecting other children's overall safety, health and well-being. In case of repetitive misbehaviour, a child may be suspended or expelled from the summer camp without a refund of the fees paid.

## Child Protection Policy

During the standard operating hours, members of staff, as part of their normal duties observe all the children and monitor any changes in a child's behaviour. Any concerns about a child will be discussed with the parents/guardians who in return are also encouraged to discuss any concerns they might have about their child's welfare with the Summer Camp Management.

Abuse may come in the form of neglect, physical, emotional and sexual. The Summer Camp is obliged to report all instances of suspected abuse to the appropriate authorities. In certain cases, the situation is discussed with the parents or guardian and if no action is taken to improve the situation immediately the Summer Camp Management reserve the right to report any abuse without any notice or discussion at its own discretion (read [MSC Safeguarding & Child Protection Policy](#)).

The Summer Camp shall follow the relevant legislation about the protection of the Child. The Summer Camp Management reserve the right to inform the Child Protection services if they have concerns for a child's well-being.

All injuries/accidents that occur during the Summer Camp activities will be recorded.

Even though a special discount is given to children of fully paid-up members, applications are strictly accepted on a **first come first served basis** irrespective of whether being a Club member or not.

- Anyone who does not wish to have their children's visual images taken/publicised is to inform the Summer Camp Management in writing via email. Failure to do so will be granting consent to the Management. (See [MSC Safeguarding & Child Protection Policy](#)).
- The Summer Camp Management reserves the right to provide the Health Authorities with contact information if required.

Whilst every effort shall be made to ensure the safeguarding of all the Children attending the Sports Summer Camp, the parents/guardians agree that they shall hold harmless the Committee of Management of the Marsa Sports Club and any of its appointed officials be it both administrative and/or coaches any liability, claim, action, losses, damages, suits and expenses including legal expenses that may be incurred as a result of any damages whether personal, physical or to property that maybe sustained by the son/daughter during his/her attendance during the Sports Summer Camp.
